In order of appearance CAT is proud to present these hand-selected professionals chosen for their high level of proficiency and breadth of knowledge:

- **Dr. David Tribble** has been the Chief Medical Officer of Alive Hospice since 2008. In his own words Dr. Tribble says; “Upon finding out what I do for a living, people often say that they could never do this work, that it must be terribly depressing and that I must be an unusual person to deal with death every day. The fact is, I deal with living every day. In hospice and palliative medicine, I go back to treating patients instead of treating diseases, and that is not depressing at all”. I think this says it all... Dr. Tribble graduated from Muhlenberg College with a BS in Natural Sciences in 1971. He then went on to graduate from Temple University Medical School in Philadelphia, Pennsylvania in 1975. He completed his internship at York Hospital in York, Pennsylvania, in 1976, and his residency in Family Medicine at the Naval Regional Medical Center in Charleston, South Carolina, in 1980. He has concentrated his practice in Hospice and Palliative Medicine since 1992.
- **Shelley Matthews** is the Assistant Director of the Southwest Area Agency on Aging and Disability in Jackson, Tennessee, where she has shared her knowledge and talents for seven years. Shelley entered the agency in the Information & Assistance Department and quickly moved to the position of Management Information Specialist. Her ability to quickly navigate the maze of State and federal benefit requirements and passion for client advocacy was recognized and she was promoted to the position of Medicaid Waiver Program Coordinator and finally as the agency’s Assistant Director. She attended Liberty University in Lynchburg, Virginia, where she was a National Debate Tournament Champion. After returning home from college she worked for the Tennessee Disability Coalition in Nashville, advocating for systems change on behalf of individuals with disabilities. - **Dr. Brian Bonfardin** received his B.A. in Religious Studies with a Minor in Pre-Med in 1985, followed by medical school at East Tennessee State University where he received his M.D. in 1990. His current positions are as follows: Clinical Assistant Professor, East Tennessee State University, Department of Psychiatry; Medical Director, Omega Substance Dependency Program in Mountain Home, Virginia; Consulting Psychiatrist, Steppenstone Adolescent Sexual Offender Program; Disabilities Consultant, Frontier Mental Health Center; and Psychopharmacology Consultant, Parent Child Services Autism Clinic and Helen Ross McNabb Center. Despite his very busy schedule, Dr. Bonfardin also maintains a private practice specializing in Autism and Developmental Disabilities, has authored several psychiatric articles and is a busy professional speaker across the U.S. and Canada.
